2009-2010 ARIZONA SNOWBOWL SEASON PASS HOLDER RULES AND REGULATIONS

CONDITIONS OF ISSUANCE:

1. This pass shall remain the property of Arizona Snowbowl and is NOT TRANSFERABLE AND NON-REFUNDABLE.
2. **If this pass is used by other than the person named hereon, or, if there is misrepresentation of age or dependent status it will result in termination of lift/pass privileges and/or prosecution under Arizona Statute — Title 13, Section 13-1802 "THEFT."**
3. **If your pass is forgotten, lost, or stolen, a day ticket will be issued one time only. If a replacement pass is necessary, a one time fee equal to the cost of an All Day Lift Ticket will be assessed. A lost or stolen pass will be replaced one time only.**
4. **NO WARRANTY IS EXPRESSED OR IMPLIED AS WEATHER CONDITIONS CAN VARY GREATLY AND AFFECT DAILY OR SEASONAL OPERATION.**

UNSAFE ACTS WILL RESULT IN PARTIAL OR PERMANENT LOSS OF LIFT/PASS PRIVILEGES WITH NO COMPENSATION.

RELEASE FROM LIABILITY (PLEASE READ CAREFULLY):

I understand and accept the fact that alpine skiing in its various forms is a hazardous sport. I realize that injuries are a common and ordinary occurrence of this sport. I agree, as a condition of being allowed to use the ski area facility and premises, that I freely accept and voluntarily assume all risks of personal injury or death or property damage, and release Arizona Snowbowl Resort Limited Partnership, United States Forest Service, and their successors, assigns, agents, employees, directors, officers, and shareholders from any and all liability for personal injury, death, or property damage which results in any way from negligence, whenever it occurs, conditions on or about the premises and facilities, the operations of the ski area including, but not limited to, grooming, ice, snow making, ski lift operations, variations in terrain, forest growth, rocks, debris, other obstacles and hazards, actions or omissions of employees or agents of the area, or my participation in skiing or other activities including terrain parks at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result.

WARNING: Under Arizona law, a skier accepts the risk of any injury to person or property resulting from any of the inherent dangers and risks of skiing, including changing weather conditions, existing and changing snow surface conditions, surface or subsurface conditions, whether marked or unmarked, collisions with natural or man-made objects, whether marked or unmarked, and the failure of skiers to ski within their own abilities.

It is agreed and understood that in the event of any suit or action between the undersigned and Arizona Snowbowl regarding this pass or any injuries occurring at the ski area, the venue shall be Coconino County Superior Court only.

CONDITIONS OF USE

If you do not agree to the terms and conditions of this Contract, do not submit the same to the Arizona Snowbowl. Your affirmative act of submitting this Ski Season Pass Contract to the Arizona Snowbowl constitutes your acceptance, with or without your signature, of all of the terms and conditions of this Contract. By submitting this Contract you agree that you have read and understood this Contract and agree to be bound by its terms and conditions and the terms and conditions of the use of the facilities.

I, the undersigned, have read and understood the terms of the above Season Pass and the Release Agreement which is an essential part of it. I am signing it freely and of my own accord, realizing it is binding upon myself, my heirs and assigns, and in the event that I am signing it on behalf of any minors, that I have full authority to do so, realizing its binding effect on them as well as myself. As a condition of holding a Season Pass identification card and being permitted to use any and all of the facilities of the ski area, I agree to all terms of the Release From Liability Agreement, Conditions of Use, and Conditions of Issuance, as stated herein.

Additionally, I certify that the information provided by me on this form is correct to the best of my knowledge. I understand that pass privileges may be revoked without refund for any false information on this form.
